Stormwater Committee-

- Joe Gearing (County)
 - Updating the County SMESCR
 - 3/4 of county 2 stage ditch projects complete
 - Plan review projects
 - Applications for Assistant Drainage Engineer now being taken
 - Data Center and Amazon projects are two of the big hitters
- Dakota Clay (city)
 - Lima vetrain memorial is 90% done (waiting on the weather for final touches)
 - Culvert rehabilitation will take place this summer
 - Jackson street Community Garden Project underway
- Lydia Archambo and Melinda DeLaRosa (County)
 - Melinda is getting into contact with municipalities for training
 - Lydia and Melinda are in annual report season
- Water in the News “WITH” – Melinda
 - Changes to “water of the state” to match the federal ruling – most of these changes pertain to wetlands
